- > Regular maintenance and technical support.

#### Terms& Conditions

- The language/framework/database applications etc used for the development of the website should be
  of the latest industrial standard with Long Term Support.
- The web modules and database structures should have provisions to facilitate the expansion of the modules.
- The websites developed should be compatible for viewing on laptops, desktops, and Mobile.
- The Software modules developed will be the property of the Krishi Vigyan Gumla, Vikas Bharti Bishnupur and will hold all the rights on these modules. The full Source code on the modules developed/ modified shall be made available to this at the time of installation of the modules. All content should be stored and kept confidential and should not reuse/ replicate/ transfer to anyone else
- The source code delivered under this agreement shall include clear and sufficient comments throughout the codebase.
- · Comments must explain the purpose of functions, classes, and complex logic to ensure readability.
- The documentation should enable other developers to understand, modify, and scale the application in the future without requiring extensive reverse engineering.
- Failure to provide adequately commented code may be considered non-compliance with the deliverables of this agreement.
- The Agency should provide all admin/ user manuals. They should also provide support for all future upgrades/ initiatives of KVK Gumla related to website. The Agency shall not sublet whole or part of the work to any other agencies.
- The Agency may engage enough manpower so as to complete the project in time. In case of default on
  the part of the Agency in carrying out any order, KVK Gumla shall be entitled to get the work done by
  any other persons and all expenses consequent thereon or incidental thereto shall be borne by KVK
  Gumla and will be deducted by KVK Gumla from any money due or it may become due to the Agency.
- Quotations must clearly specify costs module-wise including cost of AMC per year and provide a
  consolidated total.
- The quotation should include GST and other applicable taxes.
