2. On the top of envelope containing application form must have following information- Application for the post applied for, Advertisement and discipline of the post and last date of application form.
3. **Application fee:** Candidates have to submit fresh application on prescribed format along with Demand Draft of **Rs. 1000/- for UR/ OBC and Rs. 500/- for SC/ST/EWS & PWD candidate in Favour of Virendra Kumar Singh Krishi Vigyan Kendra payable at SBI, Branch Hasanganj (IFSC SBIN0012863)**. - I. Demand draft should be attached with the application form and Candidate Name, Post Applied for and Mobile Number should be mentioned in the back side of the DD.
- II. Bank charges in addition to specified application fee shall be borne by the candidate.
- III. Fee once paid will not be refunded under any circumstances.
4. **Age Limit:** For the post of Subject Matter Specialist (T6), the age should be 21- 35 years. Relaxation of 03 years in case of OBC and 05 years in case of SC/ST category as per government norms.
5. **Application through Proper Channel:** Persons already employed should submit his/her application form Through Proper Channel. Advance copy of application form may be considered subject to production of NOC/ Vigilance Clearance Certificate from employer at the time of interview.
6. A committee specially constituted will screen the application forms received for the post (T6).
7. Qualifications/eligibility conditions, age and other documents will be determined with regard to last date of advertisement of application form (also called as closing date i.e. given in the advertisement).
8. Self-Attested documents assumed to be submitted with application form:
  - ❖ Demand Draft/Receipt of Online Application Fee.
  - ❖ Recent passport size Photograph.
  - ❖ Certificates and Mark sheets of Academic Records.
  - ❖ Experience Certificate, Caste Certificate, PWD Certificate (If any).
  - ❖ High School Certificate for Proof of age.
  - ❖ All other requisite documents whichever is applicable to support claim.
  - ❖ Medical Fitness Certificate.
  - ❖ Remarks of present employer for in service candidates.
9. Application not received in prescribed format/process shall be rejected and no correspondence in this regard will be entertained.
10. ICAR Virendra Kumar Singh Krishi Vigyan Kendra, Unnao will not pay any travel expenses for attending the written exam/interview.
11. Reasons for rejection of application:
  - a. Application is incomplete and unsigned.
  - b. Full fee, if not paid/ deposited in the manner prescribed.
  - c. Candidate is underage/overage on the closing date of application.
  - d. Lack of essential qualification as prescribed in advertisement.
  - e. Applicant does not possess the requisite academic qualification, experience on closing date of filling application form and
  - f. Variation in data of Application Form and in original documents when brought for Verification/ Scrutiny-cum-Interview.

## OTHER INSTRUCTIONS

1. Before filling-up the Application Form, the candidates are advised to read General Instructions, Essential Information and Other Important Conditions section carefully.
2. The eligible and interested persons are required to go through KVK website <https://unnao.kvk4.in/> to obtain all details related to Application Form.
3. All original documents must be brought at the time of verification/scrutiny-cum-interview, whenever asked for.
4. Candidates are advised to fill their application form carefully such as Name, Father's name, Date of Birth, Category, Qualification. Candidate will be held responsible for any mistake in the data of application form and no correspondence will be entertained in this regard.
5. In order to avoid last minute rush, the candidates are advised to apply early enough. The KVK will not be responsible for any kind of postal delay or any other problem of this nature in submission of application after last date.
6. All applicants must fulfil the essential requirements of the post and other conditions stipulated in the advertisement. They are advised to satisfy themselves, before applying, that they possess at least the essential qualifications laid down for the posts. No enquiry asking for advice as to eligibility will be entertained. The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for Written Test/Interview.
7. Filling all mandatory fields are required to make your application complete. Any change in the application form will not be entertained after submission
8. Incomplete applications will not be considered and will summarily be REJECTED without any intimation. No interim correspondence shall be entertained.
9. The process of selection may be by Academic Score Card /Written Test/Interview or a combination thereof.
10. The list of short-listed candidates for Written Test/Interview will be published on the KVK Website <https://unnao.kvk4.in/> only. Corrigendum or Addendum or Cancellation to this advertisement, if any, shall be published only on the KVK Website <https://unnao.kvk4.in/> and will not be published in the newspapers. Therefore, candidates are advised to check the KVK Website regularly.
11. Action against candidates found guilty of misconduct:  
Candidates are warned that they should not furnish any particular that are false, tampered/fabricated or should not suppress any information while filling-up the application form. Suitable course of action will be proposed at the time of Written Test/Interview if a candidate is (or has been) found guilty of:
  - ❖ Using unfair means during the examination OR
  - ❖ Impersonating or procuring impersonation by any person OR
  - ❖ Misbehaving in the examination hall or taking away the question booklet or any part thereof/answer sheet from the examination hall OR
  - ❖ Resorting to any irregular or improper means in connection with his/her candidature for selection.
12. The KVK will not be responsible for any loss due to invalid/wrong E-mail ID provided by the candidate or for delay/non-receipt of information. Candidates are advised to visit the KVK Website regularly.
13. After the Written Test/Interview, in case of selections the appointment will be provisional and is subject to the caste certificate being verified through proper channels. If the verification reveals that the claim of the candidate belongs to ST/SC/OBC (non-creamy layer)/EWS is false, his/her services will be terminated forthwith without assigning any further reasons.
14. The service conditions including pay level and age of superannuation shall be as per KVK/ICAR rules.
15. The appointment of a candidate shall be subject to verification of all essential documents by the competent authority. Until the verification report of documents is received, the appointment shall be treated as provisional. In case the report with regard to his/her conducts, character, antecedents, caste certificate etc., is found to be unsatisfactory or false, the appointment shall be cancelled/terminated forthwith.
16. The selected candidates shall be required to perform duties as per the Rules of the KVK, as amended from time to time. The KVK shall be free to assign any duty as per the exigency of the situation at any time even during non-working hours/holidays which the employee shall have to perform without fail to avoid any disciplinary action.

17. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issue of the appointment letter, the KVK reserves the right to modify/withdraw/cancel any communication made to the candidates.
18. In case of any disputes, any suits or legal proceedings against the KVK, the territorial jurisdiction shall be restricted to the Courts in UP at District Court at Unnao and High Court at Lucknow/Allahabad only.
